19TP023 – Approve the Agreement between the City of Rapid City and the South Dakota Department of Transportation for accomplishing the Rapid City Area Transportation Planning Process in the amount of \$533,684.62. Harrington reviewed the Agreement between the City of Rapid City and the South Dakota Department of Transportation to conduct the Rapid City Area Transportation Planning Process. This agreement provides federal transportation planning funds in the amount of \$533,684 to conduct activities identified in the Rapid City Area MPO's 2020 Unified Planning Work Program and authorizes the reimbursement of funds to the City of Rapid City for work identified in the 2020 Unified Planning Work Program through the Transportation Planning Budget (706), including eligible activities performed by Community Development and Public Works staff.
